**Internal rules

**Order of the Director  
of Družba Halls of Residence CU  
no. 4/2021**

Order of the Director on hygiene and safety measures for the accommodation facility of Družba Halls of Residence CU in order to prevent the emergence and spread of COVID-19

In accordance with Article 7(1) of the Organisational Regulations of Družba Halls of Residence CU (hereinafter referred to as "DHR CU"), in accordance with the decisions of the Permanent Crisis Staff of the CU, the Director of the Comenius University in Bratislava, DHR CU issues the following order due to the duration of the COVID-19 pandemic and for the need to comply with the anti-epidemic measures and recommendations, in the interest of maintaining public health:

## I order

1. to all persons on the premises of DHR CU with effect from 1 September 2021 until further notice, **to respect that access to the premises of DHR CU is permitted only:**
  - a) accommodated persons,
  - b) persons working on the premises of DHR CU,
  - c) members of the public entering establishments which provide their services on the premises of DHR CU,
  - d) visitors to catering facilities on the premises of DHR CU;
2. all residents of DHR CU to observe, with immediate effect and until further notice, **the prohibition of visits** to students, staff, lecturers or other guests by persons other than those accommodated in DHR CU. During the visit the number of persons in the room must not exceed the accommodation capacity of the room. Residents are strongly discouraged from visiting between blocks and rooms. In the event of a worsening of the epidemic situation or the operational situation, as well as in the event of non-compliance with the measures in relation to visits, visits between blocks or between rooms will also be prohibited.
3. all residents of DHR CU with immediate effect until further notice to be consistent in observing the **night-time quiet hours, which are from 22.00 to 07.00;**
4. all residents of DHR CU, with immediate effect until further notice, to respect the fact that the **capacity of individual study rooms has been halved;**
5. all persons on the premises of DHR CU, with immediate effect until further notice, to comply with **the prohibition on association and assembly of more than 6 persons** for any purpose, which applies to both the internal and external areas of DHR CU;
6. all residents of the premises of DHR CU, visitors to the catering facilities on the premises of DHR CU, the public entering establishments providing their services on the premises of DHR CU **to observe the principles of M-D-H (mask, distance, hands)** with immediate effect until further notice as follows:
  - a) Wear a protective face mask (respirator in the event of a worsening of the epidemic situation) completely covering the upper respiratory tract in all indoor areas of DHR CU, including catering areas (except during meal times),
  - b) maintain a distance of at least 2 metres in all indoor areas of DHR CU,
  - c) disinfect their hands when entering buildings and in all internal areas of DHR CU that are equipped with disinfecting equipment;
7. all persons on the premises of DHR CU to comply with all health, safety, hygiene or epidemic measures specified in this order, as well as the measures of the Office of Public Health of the Slovak Republic published on the website [www.uvzsr.sk](http://www.uvzsr.sk), or the measures of the relevant state authorities, with immediate effect until further notice. In case of violation of these measures, the following persons may be banned from the premises of DHR CU. A special procedure will be followed in the case of violation of accommodation measures, when sanctions will be imposed on the residents in

accordance with the valid Accommodation Contract and the Dormitory Regulations of DHR CU, in particular a **contractual fine of EUR 100.00** or denial of access to the premises of DHR CU. In the event of a gross violation of accommodation measures, DHR CU will withdraw from the accommodation contract;

8. all residents of DHR CU with immediate effect until further notice to visit the special sub-page "I suspect or have a confirmed COVID-19 disease. What should I do?" on the main website uniba.sk, which is published at <https://uniba.sk/spravodajsky-portal/koronavirus/podozrenie-alebo-potvrdeny-vyskyt-covid-19/>, if they suspect a respiratory tract infection, as well as in the case of a confirmed COVID-19 disease. In the case of confirmed COVID-19 disease, an electronic questionnaire (form) will be displayed to be filled in after logging in via AiS2 accesses;
9. all persons referred to in para. 1 of this order, **upon entering the DHR CU, to present proof of participation in the vaccination against COVID-19 or a current test (from PCR test within 72 hours or antigen 48 hours) or confirmation of cured COVID-19 disease in the last 180 days** in accordance with the decree of the Ministry of Health of the Slovak Republic, ordering measures in case of a public health threat to restrict establishments, based on the system for monitoring the evolution of the epidemic and taking anti-epidemic measures depending on the intensity of the spread of the COVID-19 disease, the so-called COVID automaton (version 4.1 of 10.8.2021) approved by the Government of the Slovak Republic, from the level of risk Vigilance according to the OTP scheme (person in the regime vaccinated, tested, or overcome COVID-19 disease).
10. a person with symptoms of respiratory tract infection or other known symptoms of COVID-19 disease (increased body temperature, cough, vomiting, diarrhoea, sudden loss of taste and smell, other symptom of acute respiratory tract infection) will not be allowed to enter the premises of DHR CU. If the person is a resident, his/her movement in the premises of DHR CU shall be kept to a minimum and, if possible, preventive isolation shall be provided.
11. This Order cancels Internal Regulation No. 1/2021 - Director's Order on hygiene and safety measures for the accommodation facility of DHR CU in order to prevent the emergence and spread of COVID-19, dated 23 February 2021.
12. This Order shall come into force on the date of signature and shall take effect on 1 September 2021.
